### CLEANING/CONDITION OF PROPERTY:

CHECK-OUT TIME 11 AM STRICKLY ENFORCED DURING PEAK SEASON  
UPON CHECKING OUT GUEST AGREES TO WASH AND DRY AND PUT AWAY ALL  
DISHES, CLEAN OUT REFRIGERATOR. LEAVE BEDS UNMADE, PUT DIRTY TOWELS  
IN BASKETS OR IN TUB.

PLEASE REMOVE INSIDE TRASH TO CANS PROVIDED OUTSIDE.

MAKE SURE ALL GARBAGE IS PICKED UP OUTSIDE AROUND CABIN AREA.

### REPAIRS/RIGHT OF ENTRY/REFUNDS:

REPORT ALL INOPERATIVE EQUIPMENT IMMEDIATELY AS SERVICE MUST  
BE  
SCHEDULED AS SOON AS POSSIBLE. TO ACCOMPLISH REPAIRS THE REPAIRMAN  
WILL HAVE RIGHT OF ENTRY. THE OWNER WILL NOTIFY YOU OF THE TIME OF SERVICE.  
IF EQUIPMENT CAN NOT BE FIXED, WE WILL TRY TO RELOCATE YOU TO ANOTHER  
CABIN, IF NOT POSSIBLE YOU WILL ONLY BE CHARGED FOR THE NIGHTS YOU HAVE  
STAYED.

WE HAVE APPROXIMATELY 30 ACRES OF FISHING FOR YOUR ENJOYMENT HERE AT

RETREAT CABINS, PLEASE ENJOY WHILE YOU ARE HERE, WE JUST ASK YOU FOLLOW A FEW RULES.

THE MO'FISHIN' POND WILL BE PRIVATE IF IT IS RESERVED  
FAIRBANKS POND WILL BE PRIVATE IF IT IS RESERVED  
PLEASE BE RESPECTFUL AND FISH THE OTHER PONDS.

PLEASE CATCH AND ENJOY ALL THE FISH YOU CAN EAT WHILE YOU ARE HERE.  
NO STOCKING OF ICE CHEST. WE DO RESERVE THE RIGHT TO INSPECT ICE CHEST.

NO TROT LINES, NO YO YO FISHING, NO JUG FISHING IS ALLOWED.

NO CLEANING FISH ON DECKS, WE PROVIDE FISH CLEANING STATIONS AT SEVERAL OF THE CABINS WITH BUCKETS, THAT WE WILL THEN CARRY OFF THE FISH, DO NOT PUT FISH REMAINS IN GARBAGE CANS OR BAGS.

ALL BOATS ON RETREAT CABINS PROPERTY ARE FOR OUR GUESTS TO USE, YOU CAN NOT RESERVE THE BOATS, BUT WE DO HAVE PLENTY, ALSO THE DOCKS ARE FOR OUR GUESTS USE, PLEASE ENJOY.

PLEASE PUT BOAT PADDLES ON DECKS WHERE ALL GUESTS WILL HAVE FOR USE. THERE WILL BE A CHARGE OF \$50 IF PADDLES ARE NOT FOUND.

YOU ARE WELCOME TO BRING A TROLLING MOTOR, BUT NO BOATS, WE DO NOT HAVE RAMPS FOR LAUNCHING.

NO CHILDREN SHOULD BE LEFT UNATTENDED ON THE DOCKS AND SHOULD BE WEARING LIFE JACKETS WHEN ON DOCKS AND IN BOATS.

**PET POLICIES:**

RETREAT CABINS IS A PET-FRIENDLY PROPERTY.

A \$50.00 NON-REFUNDABLE PET FEE IS REQUIRED AND A \$20.00 FEE PER EXTRA DOG AFTER THAT IS REQUIRED UP TO 2 DOGS.

DOGS MUST BE CURRENT IN ALL VACCINATIONS AND MUST BE ON FLEA AND TICK MANAGEMENT SYSTEM.

SPA WILL BE CLOSED BEGINNING JUNE 1 THROUGH OCT. 1, YOU MAY DISCUSS WITH MGMT ON USING THE HOT TUB. IF HOT TUB IS FOUND USED THERE WILL BE A CHARGE OF \$150.00.

ADULTS ONLY ALLOWED IN HOT TUBS.

KEEP COVER ON SPA WHEN NOT IN USE, KEEPS WATER HOT  
DO NOT TURN TEMP PAST 102 OR DOWN PAST 100.

DO NOT ADD ANY CHEMICALS, SOAP, BUBBLE BATH, THESE ITEMS WILL CLOG FILTERS AND RESULT IN US HAVING TO CLEAN THE TUB NUMEROUS TIMES AND WILL RESULT IN AN EXCESSIVE CLEANING FEE FOR GUEST.

THE SPA IS NOT A POOL, OVERUSE WILL AFFECT THE WATER QUALITY.

DO NOT SIT OR STAND ON COVER, REPLACEMENT COST IS \$400.00.

IF WATER LEVEL IS FOUND LOW AND HOT TUB IS SUCKING AIR, A FEE OF \$150 WILL BE CHARGED. PLEASE USE WATER HOSE TO FILL TUB ABOVE BASKET WHERE IT NO LONGER SUCKS AIR.

SPA IS SERVICED AFTER GUEST VISIT. IF EXCESSIVE CLEANING IS REQUIRED THERE WILL BE A CHARGE OF \$150.00.

TAKE CARE WHEN ENTERING AND EXITING HOT TUB.

THOSE GUESTS, WHO ARE PREGNANT, HAVE HEART PROBLEMS, ASTHMA OR POOR HEALTH SHOULD NOT USE THE HOT TUBS. ALCOHOL USE INCREASES THE INTENSITY OF SPA USE. PLEASE MONITOR YOUR OWN HEALTH CONDITIONS BEFORE USING SPA.

Further, guest will not use soaps, bath oils, bubble baths, perfumes, or bath salts in the hot tub and no eating in the hot tub. If bath products, glass, grass, mud / food are found in the hot tub after check out, there will be a charge of \$150.00 for the additional

cleaning of the spa.
